NOTES:

- This is a recommended **MAXIMUM** fee schedule

NOTE #1 This is a schedule including auto allowance unless travel is deemed by the contracting parties to be significant and then auto allowances, in addition to the maximum fee, may be negotiated by the two entities involved. This does **NOT APPLY** to CCS Playoffs and no mileage will be paid to officials working the Section Playoffs.

This schedule is intended **ONLY** for officials who are members of a CIF accredited Official Association. Leagues or schools or districts may contract for lesser amounts than the maximum fees included herein.

When it is necessary to utilize officials from a non-CIF accredited association, schools and leagues are encouraged to pay no more than 75% of the maximum fee schedule.

NOTE #2 When officials report for a contest as scheduled and the contest **has been Cancelled or rescheduled** without direct and timely notice, the officials shall receive a full game fee.

NOTE #3 **For baseball, soccer & softball;** in the case of a rainout the officials will receive full pay once the contest begins,

NOTE #4 Officials for all contests will be contracted with local associations. CCS will only utilize CIF-accredited officials associations for all CCS playoff contests.

NOTE #5 **For CCS Playoffs,** Officials shall receive the maximum Varsity fee for the number of officials, plus 35% unless notice otherwise in the fee schedule.

NOTE #6 For a contest not included in the above schedule, leagues or schools may negotiate a fee with their local official's association.

NOTE #7 When an official is assigned to or works any contest alone, the fee is 150% of the schedule fee except where noted elsewhere in this schedule.

MINIMUM EXPECTATIONS OF CCS-MEMBER SCHOOLS

While the individual officials' association with which we contract for officials vary in size, scope and degree of organization, there are certain standards that all associations in the Central Coast Section must uphold, if they wish CCS member schools' to contract with them for officials.

It is the expectation of the CCS that all the standards required by CIF in order for an association to be accredited will be followed by all associations contracting with CCS member schools.
